AUTHORIZATION FOR EMERGENCY MEDICAL TREATMENT

This authorization complies with the provisions of Section 25.8 of the California Civil Code, and shall remain effective for the full school year unless revoked in writing and delivered to said agent(s). EMERGENCY INFORMATION

Dear Parents or Guardians:

One of the most important responsibilities we have as parents, students, and school employees is being prepared in case of an emergency.

Various types of emergencies may occur during the school day. A pupil may become ill or get injured at school, or a major earthquake may strike unexpectedly. By being prepared in advance, we can minimize injury and confusion.

We need your cooperation on a very important matter. During an emergency, we may need to reach you or a designated representative during school hours. This information must be on file at the school. To help us serve you, please complete the Emergency Information Card and return it to Granada Hills Charter High School.

Your cooperation is greatly appreciated. Thank you.

NOTICE TO PARENT OR GUARDIAN OF RIGHTS RELATING TO CERTAIN SCHOOL ACTIVITIES

The Education Code (EC) requires that each parent or legal guardian (known as the pupil's legal custodian) be notified of the following code sections (the sections have been paraphrased for your convenience, but for further explanation it is recommended that complete sections be read or interpreted by your school administrator):

EC-48207 When the school district is notified by a pupil's legal custodian that the pupil has a temporary disability and is residing in a hospital or residential health-care facility within its boundaries, it is required to make arrangements for individualized instruction. It is the primary responsibility of the legal custodian to notify the district of such disability (EC-48208).

EC-51550 Upon the written request of a pupil's legal custodian, a pupil may be excused from attending any class session in which human reproductive organs may be analyzed, illustrated or discussed. Written or audio visual material other than a textbook may be reviewed by the pupil's legal custodian.

EC-51240 Whenever any instruction in health, family life education or sex education conflicts with religious beliefs and upon written request of the pupil's legal custodian, a pupil may be excused from part of training that conflicts with these beliefs.

EC-49403 To cooperate with a local health officer in the prevention and control of communicable diseases, the district may permit licensed physicians to administer an immunizing agent to any pupil with written approval of the pupil's legal custodian.

EC-49451 Upon written request of a pupil's legal custodian, a pupil may be excused from taking a school physical examination. A pupil may be sent home if there is good reason to believe that the pupil has an infectious or contagious disease; and will not be permitted to return until school officials are satisfied there is no infectious or contagious disease.

EC-49455 Upon enrollment in a California elementary school, a pupil's vision shall be appraised for visual acuity by a school nurse or other authorized person and again at least every three years until grade 8. Male pupils only shall be appraised once for color vision. Any pupil may be excused from the vision examination if the legal custodian can provide a report from a physician or optometrist; or upon written request if the examination conflicts with religious beliefs, provided that the legal custodian belongs to a well-recognized religious organization.

EC-32390 Upon enrollment of a pupil in a California public school, a legal custodian shall provide written permission to have the pupil fingerprinted; and be notified in writing that the approval may be withdrawn at any time. Documents containing the pupil's fingerprints shall be given only to a pupil's legal guardian.

EC-42805 Upon written request of a pupil's legal custodian and approval of the principal or administrator, a pupil shall be excused from school for justifiable personal reasons, including but not limited to court appearances, religious holidays or ceremonies, and employment conferences. An excused pupil shall be allowed to complete all assignments and tests missed during such absences.

EC-49423 Upon written permission from a pupil's legal guardian and written detailed request of the pupil's physician, a school nurse or other designated person may assist the pupil in taking prescribed medication during the school day.

EC-49480 The pupil's legal custodian shall inform the school nurse or designated certificated employee of the pupil's continuing medication regimen for non-episodic condition, the current dosage, and the name of the supervising physician. With the consent of the pupil's legal custodian, the designated school may communicate with the physician and may counsel with school personnel regarding the possible effects of the drug on the pupil's physical, intellectual, and social behavior as well as possible behavioral symptoms, side effects, and the effects of omission or overdose.

EC-56031 Any handicapped pupil for whom a special education placement is unavailable or inappropriate may receive services in a private nonsectarian school. (Specific information may be obtained through the Psychological Services Section at Los Angeles Unified School District Region Administrative Offices or the Special Education Division).

EC-49472 School Districts may provide medical or accident insurance. Granada Hills Charter High School does provide medical or accident insurance for pupils who are injured in a school-sponsored activity, while on the school premises, or while being transported to and from school.

EC-46010.1 School authorities may excuse any pupil from school for the purpose of obtaining confidential medical services without the consent of the pupil's legal custodian.

EC-56040 Every individual with exceptional needs who is eligible to receive educational instruction, related services, or both shall receive such educational instruction and/or services as appropriate to the pupil at no cost to the pupil's legal custodian.

EC-49512 Legal custodians shall be advised of the state program that provides for the nutritional needs of pupils during school hours. Free meals shall be provided to any pupil based upon the annual income of the pupil's household. (Specific information may be obtained from the Granada Hills Charter High School Food Service Director).

EC-46014 Upon written consent of a pupil's legal custodian, a pupil may be excused from school to participate in religious exercises or instruction.
